Parking Information

The Hyatt Regency Riverwalk Hotel offers self-parking as well as valet parking for hotel guests in the Hotel Parking Garage located across the street from the main hotel entrance. Valet parking is available at the hotel's front entrance. Hotel parking rates are as follows:

- \$29.00 + tax for overnight Self-Parking per day
- \$39.00 + tax for overnight Valet parking per day
- \$27.00 flat rate for daily drive-in Valet parking

Other public parking lots and garages are located nearby within 2-3 blocks from the hotel and offer overnight parking at lesser daily and hourly rates.

SA International Airport

The San Antonio International Airport is approximately 8.25 miles from the Hyatt Regency San Antonio and the Downtown area. The airport is located at the juncture of NE Loop 410 and Hwy 281 N. with easy access to and from the interstate, and is open 24 hours a day.

To reach the airport from the hotel, exit on Losoya Street (one way). At the intersection North of Market Street, turn left to I-37 North. (1/2 mile). Follow I-37 North (merges with Highway 281 North) to the San Antonio International Airport exit (approximately 8 miles) from airport to hotel.



Bill Fulton Director, Kinder Institute for Urban Research Rice University

William Fulton is Director of the Kinder Institute for Urban Research at Rice University. He is a former Mayor of Ventura, California, and Director of Planning & Economic Development for the City of San Diego. In his career, Mr. Fulton has also served as Vice President for Policy at Smart Growth America, Principal in the California-based urban planning firm now known as PlaceWorks, and Senior Fellow at the Sol Price School of Public Policy at the University of Southern California. He is the founding editor and publisher of CaliforniaPlanning & Development Report and author of five books, including *Guide to California Planning*, the standard urban planning textbook in California, and *The Reluctant Metropolis: The Politics of Urban Growth in Los Angeles*, which was an L.A. Times bestseller.

At the Kinder Institute, Fulton coordinates Rice's research partnership with the City of Houston and its involvement with the MetroLab Network. Rice and Houston are currently exploring ways to use Smart City technology to improve both the city's operations and its policymaking process. He holds master's degrees in mass communication from The American University and urban planning from UCLA. 1.0 CM





#3 - Sustainable Water Planning

Fri, Nov 4: 8:30 am – 11:45 pm

Participants will join San Antonio Water System (SAWS) to take a tour of their new inland desalination plant. The state of the art H2Oaks plant will treat brackish groundwater from the Wilcox aquifer using reverse osmosis technology to supply San Antonio with 12 million gallons of water a day in Phase 1. In a unique efficiency of use, SAWS also has on the same property an aquifer storage and recovery facility that stores excess permitted water from the Edwards Aquifer in the Carrizo Aquifer for use during our dry South Texas summers and produces local Carrizo groundwater. **3.0 CM**





- Each team's recommendations will be posted at the table for their respective TX planning program
- Conference attendees will be encouraged to take a look at the recommendations
- After the Conference UTSA will produce a final report that incorporates the best ideas from the 5 teams


