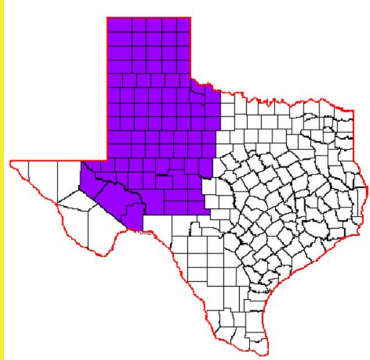

Featured Projects

This month, the following cities have volunteered to share a featured project. We hope these examples provide your city with some helpful information on implementing its own initiatives.

City of Lubbock

The City of Lubbock is creating a new Unified Development Code (UDC) which includes an update its Zoning Code to be consistent with its 2040 Comprehensive Plan. In addition to review and rewrite of the Zoning Code, it includes unification of zoning, subdivision, sign, and drainage regulations, as well as standards for design and historic districts, manufactured homes and recreational vehicle parks, and other development regulations.

The Zoning Code was adopted in 1975; on May 28, 2019, City Council voted unanimously to adopt the resolution by staff authorizing the Mayor to execute a Professional Service Contract for Kendig Keast Collaborative to develop the UDC. The entire process is expected to take 22 months, and is one of the top priorities of PlanLubbock 2040, which was adopted in December of 2018.

City of Midland

On May 28, 2019, Midland City Council adopted a new zoning ordinance that will take affect on July 1, 2019. The ordinance was adopted in accordance with Midland's Tall City Tomorrow comprehensive plan. Among other things, it is intended to: lessen congestion in the streets, prevent the overcrowding of land and air, and facilitate the adequate provision of transportation, water, wastewater, schools, parks, and other public requirements. City of San Angelo

On May 21, 2019, San Angelo City Council approved amendments to its current and parking and loading standards in its Zoning Ordinance. Consistent with other comparable cities in West Texas, Planning Staff examined reducing its minimum parking requirements while still ensuring adequate parking; providing minimum spacing, maneuvering, and paving standards to ensure longevity of its parking lots; and to allow for options and alternatives to provide flexibility in meeting parking requirements. Recommended changes adopted by Council included:

- Requiring expansion of land area not subject to a building permit to also provide parking.
- Requiring a parking lot permit for new stand-alone parking areas or additions to existing stand-alone parking lots not currently required unless they are associated with a building permit.
- Reducing parking for offices, furniture and appliance stores, and retail stores above 20,000 square feet.
- Increasing parking for uses already deficient to bring up to current demand.
- Require all parking areas are adequately paved and striped.
- Allow the Planning Director to administratively approve reduced parking, loading, and drive-thru stacking spaces where appropriate.
- Allow up to 50% of required parking spaces to be on the street, increase distance of off-site parking to maximum of 500 feet from lot with facility or activity.
- Changes to drive-thru stacking requirements, including new parallel parking standards.

Hot Topics

Design Standards: House Bill 2439

HB2439 was signed into law earlier this month, prohibiting city governments from regulating aesthetic finishing materials, essentially restricting cities from implementing minimum design standards except for the minimum installation and construction requirements outlined in the National Building Code.

Concerns include:

- Adverse affects on economic development:
- Prohibiting cities to regulate design can reduce quality of design particularly in commercial or mixed-use areas
- Disturbed aesthetics: Downtowns and scenic places without design control could allow colors and materials inappropriate for area
- Infill projects would not have to match current development standards leading to design inconsistencies
- Bill is retroactive and would affect existing zoning ordinances and planned developments already adopted and constructed.

HB 2439 provides an exception for historic buildings and certain other areas if they meet certain state guidelines, but many do not. The Bill will take effect on September 1, 2019. Subdivision Shot Clock: House Bill 3167

HB3167 was signed into law earlier this month, changing the 30 day requirement to a limitation on approve or disapprove, not simply act on. Written notice of disapproval listing all reasons for disapproval is also required, and the legislation has the potential to even further complicate the approval process.
