Gary noted that the conference impact will be known soon and the dues increase goes into effect October 1, so we may be able to adjust the budget soon. The budget presented is conservative and does not dip into budget reserves, but does include a deficit. Chance Sparks suggested we use reserve account to cover the deficit amount

# Heather Nick motioned to approve the budget with an amendment to show revenue from the reserve fund to cover the deficit. The motion was seconded by Doug McDonald and passed unanimously.
